



# **SA101A, SA101B, SA100A**

Self-powered outdoor siren for intrusion detection systems.

# 1 DESCRIPTION

SA101A, SA101B, SA100A are outdoor sirens.

Operation takes place in **positive voltage reference fall** mode: while the siren is idle, a voltage is constantly applied to the reference terminal; in alarm condition, the voltage interruption causes sound activation.

SA101A and SA101B feature two 4-Ohm horns.

SA100A features a single horn.

The sirens feature:

- front LED beacon synchronized with sound emission (orange for SA101A and SA100A, blue for SA101B)
- status LED (blue for SA101A and SA100A, orange for SA101B)


Additional visualisation functions can be enabled by cutting specific jumpers.

The sirens are equipped with an external plastic cover and an internal metal cover.

A microswitch for protection against cover opening and removal from the wall is present.

SA101A, SA101B, SA100A are certified IMQ - Security Systems according to EN 50131-4, grade 3.




Check the mounting surface is perfectly flat. Make sure the microswitch pin does not fall into holes, gaps or cracks on wall surface.


Opening the housing



- unscrew the fixing screw A
- separate external cover from the base
- unscrew the internal cover fixing screws B




- remove the internal cover following the instructions shown on the label
- Base wall mount





- feed unpowered cables through hole C
- fix the base to the surface using screws and dowels
- arrange the battery in the specific space
- wire the battery to the onboard connector

- Wirings
- wire ALIM. 14,4V terminals to the power source (on control unit, if equipped with 14V SIR terminals, or from external power supply unit) for battery charging




 wire SIR AA RIF. terminal to the reference voltage for siren control







The siren uses two indications at the same time to notify alarm status: audible (horn activation) and visual (beacon activation) indication.

In alarm mode, the siren keeps the sound signal on for 5 minutes maximum.
