# 1 DESCRIPTION

MD4GE is a LTE module that allows connecting to the control unit through mobile network.

The module provides 2G, 3G and 4G connectivity for remote control, connection to e-Connect and voice/SMS alarm message sending.

Voice calls are supported over 2G and 3G connection.


Over 3G connectivity, it is possible to keep a voice call and the communication through the e-Connect data channel both active at the same time.

MD4GE features a connector to wire an external antenna.

Optional antenna kits are available (ANT4GEXA2, ANT4GEXA15).

MD4GE is compatible with Villeggio NG-TRX and Pregio series control units.

The electronic board of the detector may be damaged by electrostatic discharges.


The installer must completely avoid any presence of

Disconnect power supply before installation.


#### Inserting the SIM card

 get a SIM card and disable its PIN code using a mobile phone




- press on the indicated area (A) with a pencil tip
- remove the tray and position the SIM on it
- reinsert the SIM tray inside the slot until it clicks in

#### Installing the module



 insert the spacers (supplied) in the holes on proper area on control unit board (indicated by C)

- **B** Module
- 1 3MA screw
- 2 Hex nut
- 3 Lock washer
- 4 3MA nut
- If you are using a VILLEGGIO control unit on means of transport, use the kit including screws, hex nuts and spacers instead of the standard nylon spacers. Tighten the nut firmly.
- align the spacer holes and the module connector with the corresponding components on the control unit board
- plug the module to the control unit board

# Mounting on VILLEGGIO NG-TRX control units

Use MD4GE together with kit ANT4GEXA2 or ANT4GEXA15.

 assemble the kit where necessary, following the instructions reported on its manual



- feed the antenna cable free end in the control unit case



- cover the antenna cable with the protective sheath




- join the connectors: tighten them manually first, then use spanners
- use the sheath to cover the connectors




 use a nylon tie to fasten the sheath and the connectors in position

# Mounting on PREGIO1000 or PREGIO2000 control units

Connect the ANT4G90 antenna to the antenna connector.




- remove front cap




- **1** Antenna base
- 2 Lock washer
- **3** Nut (tighten with 14 mm spanner)


- insert the antenna connector in the front hole



- 1 Nut (tighten with 8 mm spanner)
- fasten the antenna by tightening the nut



cut the protection grommet along the indicated dashed lines



- insert the grommet on the antenna

# 5 STARTING THE DEVICE

#### **Module registration**

- enter installer menu (installer code + OK) on keypad
- use arrow keys ↑ or ↓ to go to REGISTER MODULES option
- press **OK** to enter the menu
- use arrow keys ↑ or ↓ to reach the module to register
- press **OK** to register the module: the unit will beep for confirmation
- press **STOP** to exit the menu

#### 6 OPERATING MODE

To manage MD4GE via BrowserOne:

- install BrowserOne 3.9.25 or above
- load one of the following modules, according to control unit:

Villeggio 8.9.13 module (or higher) module Pregio 2.7.4 (or higher)

/ Remote assistance via GSM modem is not supported.
